## COVID-19, ONE YEAR LATER BETA RHO SUCCESSFULLY MINIMIZES IMPACT OF VIRUS

**T**he abrupt transition to a purely online learning format last spring changed almost every aspect of our college experience. Given that the pandemic seemed to be out of our control, the best we could do was hope that things would settle down over the summer and that we could return to normal in the fall.

As the summer rolled on, it became more and more clear that the typical ways in which our school and community operate would not soon return. This meant that we needed to implement a plan for how the chapter would operate under the guidelines and restrictions of Sigma Chi, MSU, and our local health authorities. The goal of this plan was to reduce the spread of COVID-19 within the chapter and to work out a way to maintain key aspects of chapter operations. This planning was done over frequent meetings throughout the summer between our active executive team and the Beta Rho House Company.

The plan would affect all aspects of chapter operations. Procedures regarding how social events would look, how frequent the kitchen needed to be disinfected, and how the chapter would react to an internal active case were only a few of the things to consider. Recruitment was an area that many of the fraternities across campus struggled with during the fall. However, we did an excellent job in implementing COVID-compliant changes that still allowed us to recruit top quality men. Most of these changes included masks, overflow venues for recruitment events that would have otherwise exceeded group size restrictions, and conducting online interviews.

As cases throughout Gallatin County fluctuated and rose across campus, we succeeded in limiting our exposure and mitigating the spread within the chapter. Over the course of the semester, the chapter house only experienced two cases, and our brothers, in accordance to the implemented procedures, were able to prevent the virus from spreading further through the house. Our executive team met throughout the semester and winter break to refine and optimize our operating procedures to accurately address changes in local guidelines and to better fit goals as a chapter.

We are extremely proud of the perseverance and self-control that our brothers displayed throughout the fall semester as we carried out the execution of this plan. We look forward to a successful spring semester, and we hope everyone stays safe and healthy!

"My experience with Sigma Chi was and is invaluable. When attending law school, my classmates were under constant stress and pressure," Dillon said. From heading up to the mountains, camping trips, and bonfires at Hyalite Canyon to sororities pranks, skiing at Bridger Bowl, and working on Homecoming floats, Dillon never had a dull moment when he was spending time with his brothers during college. The special friendships Dillon formed through Beta Rho made it an easy decision for him to remain involved with the fraternity as an alumnus.

"I love volunteering as a facilitator for Krach Transformational Leaders Workshop and working with chapters to develop their strategic plans," Dillon said. "I've spent the last three years facilitating and hope I can continue volunteering throughout my life. I also recently took a road trip along the west coast and saw several alumni that I graduated with along the way."

Along with achieving immediate success after graduating from MSU, it's been rewarding for Dillon to see many of his brothers thrive early on in their respective careers.

"One interesting thing is that there has been a member of Beta Rho in five of the last six law school classes at the University of Montana (and notably no Beta Deltas)," Dillon said. "**Calder Thingvold '14**, who was one of my pledge brothers, and **Eli Inabnit '12**, who was Consul my sophomore year, each obtained federal clerkships in Billings and Missoula, respectively. Both remain close friends of mine."

The high Sigma Chi standard that was set at Beta Rho when Dillon was a freshman has only been raised in recent years. He's excited to see what's in store for the active chapter's collegians and future members and is thankful to be a better man because of Beta Rho.

"Beta Rho continues to be an environment where guys can grow and prosper, but even more importantly where they can have similar hilarious and fun experiences to the ones I had," Dillon said. "I hope to see that trend continue indefinitely."

## House Construction Timeline

**O**n the renovation front, we have collected the bulk of alumni pledges; all should be in by the end of this year. The Building Committee has begun work with a Helena architect, Scott Cromwell, to start down the detailed planning road. Scott led the architecture team that recently did the major renovation at the AGR chapter house, and he also did the architectural concepts for our fundraising brochure. His team visited Beta Rho in December to do laser measurements for every portion of the house, which has enabled them to get down to work and come up with some detailed options for the dorm side of the house.

It seems Bozeman is a hotbed of construction right now as the "virtual workforce" leaves the big cities and flocks to great lifestyle locations in the country. We had hoped to renovate the dorm side this summer, but with COVID-19 slowing down everything on the planning side

and the shortage of supplies and contractors in Bozeman, we now plan to delay the start of construction by a year.

Two major issues we are grappling with are ADA requirements and the amount of space that can be considered "educational."

As far as scheduling goes, the project will be divided into two stages. The plan is to do the dorm side of the house as stage one, likely during the summer of 2022. The rest is to be completed the following summer.

We also partnered with one of MSU's clubs, Circle K, to perform a campus-wide trash cleanup. In addition to raising over \$4,000 for the Huntsman Cancer Institute, we strive to support our local Bozeman Cancer Support Community by providing them yardwork to help improve their campus.

An event that we are happy to do alongside the MSU student body is the "Can the Griz" food drive. This year, we donated over 250 pounds of food to Bounty of the Bridgers Food Bank on campus. Each semester, we are proud to host the Red Cross at our chapter house for a community blood drive. This semester, we gave an outstanding 32 units of blood. The brothers of Beta Rho are always glad to help, and we look forward to hosting and participating in future events that benefit our campus and community.

One area that our chapter is very proud of from this fall is recruitment. Despite COVID-19 restrictions and using new recruitment strategies, we initiated 17 new brothers into our order. This was the highest count from any fraternity on campus for the fall. In academics, our chapter GPA was 3.04 and we had 30 members make the Dean's List (3.5 GPA or higher). We are extremely excited to see such high performance, especially as the largest fraternity on campus. It's a big deal to outperform the all-fraternity, undergraduate male, and all-undergraduate GPAs.

Overall, the brothers of Beta Rho are very proud of what we were able to accomplish over the unprecedented nature of this past semester. We are excited to continue our momentum and progress this spring.

Throughout this semester, we planned several philanthropy events, including a raffle, a March Madness bracket fundraiser, and a car wash. We also look forward to volunteering at Bozeman's food bank, Habitat for Humanity, and hosting another blood drive.
